A DOI advisory committee recently recommended that the Department privatize more NPS campgrounds. Other recommendations include allowing services such as wi-fi and food trucks. Coalition Chair Phil Francis **spoke** with National Parks Traveler about the troubling ramifications of this recommendation. CPANP also issued a statement, noting that "the suggested initiatives will increase noise pollution and crowding at locations where visitors often go to get away from the trappings of everyday life." ## **Target Shooting at Bears Ears**

CPANP joined with partners and submitted comments on the proposed target shooting closures of certain lands at Bears Ears National Monument. We support the BLM's decision to prohibit target shooting at campgrounds, developed recreation sites, petroglyph sites, and structural cultural sites within the planning area, though we believe the Monument must be entirely closed to target shooting to adequately protect monument objects, ensure public safety, and comply with applicable laws. # Fy 2020 Appropriations Updates

The Coalition issued a statement on the Senate's FY2020 Appropriations bill for Interior, Environment, and Related Agencies. While not perfect, it demonstrates support for our National Park System and National Park Service employees with the rejection of all proposed cuts to programs and parks, and proposed program elimination and a requested increase to the NPS operational budget request. We also submitted a <u>letter</u>, in partnership with the Second Century Action Committee, to Congressional Leadership with several specific appropriations request. However, CPANP strongly opposes the use of unobligated funds to accomplish the illadvised DOI reorganization. Read our letter below.
