- The Coalition continued to encourage
 the Administration to designate new
 national monuments and protect lands
 at risk. We issued a <u>press release</u>
 commending Interior Secretary
 Haaland's visit to Avi Kwa Ame and
 signed a <u>letter</u> in support. Additionally,
 we joined a <u>letter</u> to President Biden
 urging him to establish the Camp Hale Continental Divide National Monument
 and published a <u>blog post</u> reflecting on
 its meaning.
- We joined a <u>letter</u> to DOI requesting the Final Environmental Impact Statement for the James River Transmission line be modified so that the preferred alternative include a decommissioning and removal of the the existing transmission line within 20 years. If this alternative is rejected, the letter requests the Department file a predecisional referral with the CEQ.
- The Coalition joined in a <u>letter</u> to Virginia's U.S. Senators and northern Virginia Representatives expressing concerns over Prince William County's rapid process to approve construction of a data center adjacent to Manassas National Battlefield Park.
- We joined NPCA in a <u>letter</u> to the BLM providing detailed recommendations for the development of the draft resource management plan for Grand Staircase-Escalante National Monument, including a recommendation that BLM adopts the most protective management alternative for the monument.

For over 25 years, the Friends of Peirce Mill (FOPM) have worked with the National Park Service (NPS) in Rock Creek Park to preserve, restore, and interpret the last working gristmill in Washington, D.C. Using Centennial Challenge funding, NPS and FOPM are about to restore the stone building's historic Oliver Evans milling system - a four story mechanical marvel that turns grain into flour.
