- to use the *Antiquities Act* to protect critical landscapes and cultural treasures by designating additional national monuments.
- The Coalition signed a <u>letter</u> to Congressional appropriators supporting disaster relief provisions in the final Fiscal Year 2023 appropriations to enable public land management agencies in their recovery from the multiple national disasters of the year.
- The Coalition joined in <u>requesting</u> the Department of the Interior to pause oil and gas lease sales in the second quarter of 2023 until rulemaking to reform the onshore oil and gas program.
- The Coalition <u>requested</u> the Internal Revenue Service disallow renewable energy tax credits for projects on public lands within a certain radius of the National Park System and and National Historical Landmarks associated with the incarceration of Japanese Americans during World War II, which would include Amache and Minidoka.
- The Coalition joined with numerous organizations in providing detailed scoping <u>comments</u> on the proposed management plan for Bears Ears National Monument.

#### **Announcements**

The Rosenwald Park Campaign was created to promote the establishment of a multi-site National Park celebrating the life and legacy of <u>Julius Rosenwald</u>. The Campaign was founded in 2016 with the support of the National Parks Conservation Association and the National Trust for Historic Preservation. The Coalition was the third group to express its support for the park.

To date, over 170 organizations have officially endorsed the creation of the Julius Rosenwald & Rosenwald Schools National Historical Park. While they represent a broad spectrum of groups, including national park advocacy organizations, synagogues, churches, and Black and Jewish organizations, the Campaign continues to seek additional organizations to support the efforts of the Campaign. Please consider reaching out to your own network and asking the non-profit organizations that you are are associated with to consider signing on in support of creating a Julius Rosenwald & Rosenwald Schools National Historical Park.
