Finally, a special thanks to Mike Murray, who is stepping down after dedicating ten years of work to the Coalition.

Advocacy Actions

Below are highlights from the Coalition's actions in December:

- Appropriations for Fiscal Year 2024 remain unfinished and a priority. The Coalition joined in submitting a <u>letter</u> to the Senate expressing general support for their proposed funding for NPS and a second <u>letter</u> expressing concerns with numerous riders which would impede reforms to BLM's oil and gas leasing program.
- The Coalition continues its engagement on numerous park level management issues. We provided comments detailing significant concerns with the Ambler Road supplemental environmental impact statement for **Gates of the** Arctic National Park and Preserve. Along with NPCA, the Coalition provided comments on visitor use, access, and experience at **Arches** National Park and the long range day use visitor access strategy and environmental assessment for **Rocky** Mountain National Park.
- The Coalition provided comments in support of Director's Order 36, Housing Management, and submitted a **letter** to Congress in support of H.R. 5995, the Federal Retirement Fairness Act.
- The Coalition continues to support additional protections for public lands through use of the Antiquities Act. We issued a **press release** in support of local efforts for the designation of a Mimbres Peaks National Monument and thanked DOI for its public meeting on the expansion of Berryessa National Monument.
