Advocacy Actions

Below are highlights from the Coalition's work in January:

- The Coalition provided detailed comments on the proposed revisions to evaluation and authorization procedures for fixed anchors and fixed equipment in wilderness areas. Among other things, the letter requests that the NPS identify why it is considering this change and expresses concern that this change could set a precedent for other recreational activities in wilderness areas.
- The Coalition engaged on numerous park-related issues. We provided comments to New River Gorge National Park and Preserve as they consider the demolition of structures within the park. We also sent a letter regarding concerns over trespass livestock at Big Bend National Park.
- Coalition Chair Phil Francis discussed the negative impact a continued government shutdown could have on NPS employee morale.
- The Coalition continues its work to protect parks from the impacts of oil and gas development and joined in detailed comments to BLM on the proposed New Mexico and Nevada 2024 second quarter proposed oil and gas lease draft environmental assessment and draft finding of no significant impact.
- The Coalition remains an active participant in issues impacting air quality and concerns over regional haze.
